Direct Debit Request Service Agreement

Definitions

account means the account held at *your financial institution* from which *we* are authorised to arrange for funds to be debited.

agreement means this Direct Debit Request Service Agreement between *you* and *us*.

business day means a day other than a Saturday or a Sunday or a public holiday listed throughout Australia.

debit day means the day that payment by *you* to *us* is due.

debit payment means a particular transaction where a debit is made.

direct debit request means the Direct Debit Request between *us* and *you*

us or *we* means *United Mineworkers South Western District*, the Debit User *you* have authorised by signing a **direct debit request**.

you means the customer who signed the **direct debit request**.

your financial institution is the financial institution where *you* hold the **account** that *you* have authorised *us* to arrange to debit.

1. Debiting your account

1.1 By signing a **direct debit request**, *you* have authorised *us* to arrange for funds to be debited from *your account*. *You* should refer to the **direct debit request** and this **agreement** for the terms of the arrangement between *us* and *you*.

1.2 *We* will only arrange for funds to be debited from *your account* as authorised in the **direct debit request**.

1.3 If the **debit day** falls on a day that is not a **business day**, *we* may direct *your financial institution* to debit *your account* on the following **business day**.
If *you* are unsure about which day *your account* has or will be debited *you* should ask *your financial institution*.

2. Changes by us

2.1 *We* may vary any details of this **agreement** or a **direct debit request** at any time by giving *you* at least fourteen (14) days' written notice.

3. Changes by you

3.1 Subject to 3.2 and 3.3, *you* may change the arrangements under a **direct debit request** by contacting *us* on **P O Box 364 Lithgow NSW 2790 Ph: (02) 6351 3287**.

3.2 If *you* wish to stop or defer a **debit payment** *you must* notify *us* in writing at least **Seven (7)** days before the next **debit day**. This notice should be given to *us* in the first instance.

3.3 *You* may also cancel *your* authority for *us* to debit *your* account at any time by giving *us* **Seven (7)** days notice in writing before the next **debit day**. This notice should be given to *us* in the first instance.

4. **Your obligations**

- 4.1 It is **your** responsibility to ensure that there are sufficient clear funds available in **your** account to allow a **debit payment** to be made in accordance with the **direct debit request**.
- 4.2 If there are insufficient clear funds in **your account** to meet a **debit payment**:
- (a) **you** may be charged a fee and/or interest by **your financial institution**;
 - (b) **you** may also incur fees or charges imposed or incurred by **us**; and
 - (c) **you** must arrange for the **debit payment** to be made by another method or arrange for sufficient clear funds to be in **your account** by an agreed time so that **we** can process the **debit payment**.
- 4.3 **You** should check **your account** statement to verify that the amounts debited from **your account** are correct
- 4.4 If **United Mineworkers South Western District** is liable to pay goods and services tax ("GST") on a supply made in connection with this **agreement**, then **you** agree to pay **United Mineworkers South Western District** on demand an amount equal to the consideration payable for the supply multiplied by the prevailing GST rate.

5. **Dispute**

- 5.1 If you believe that there has been an error in debiting **your account**, **you** should notify **us** directly on **P O Box 364 Lithgow NSW 2790 Ph: (02) 6351 3287** and confirm that notice in writing with **us** as soon as possible so that **we** can resolve **your** query more quickly.
- 5.2 If **we** conclude as a result of our investigations that **your** account has been incorrectly debited **we** will respond to **your** query by arranging for **your financial institution** to adjust **your** account (including interest and charges) accordingly. **We** will also notify you in writing of the amount by which **your account** has been adjusted.
- 5.3 If **we** conclude as a result of our investigations that **your account** has not been incorrectly debited **we** will respond to **your** query by providing **you** with reasons and any evidence for this finding.
- 5.4 Any queries **you** may have about an error made in debiting **your account** should be directed to us in the first instance so that **we** can attempt to resolve the matter between **us** and **you**. If **we** cannot resolve the matter **you** can still refer it to **your financial institution** which will obtain details from **you** of the disputed transaction and may lodge a claim on **your** behalf.

6. **Accounts**

- You** should check:
- (a) with **your financial institution** whether direct debiting is available from **your account** as direct debiting is not available on all accounts offered by financial institutions.
 - (b) **your** account details which **you** have provided to **us** are correct by checking them against a recent **account** statement; and
 - (c) with **your financial institution** before completing the **direct debit request** if **you** have any queries about how to complete the **direct debit request**.

7. Confidentiality

7.1 *We* will keep any information (including *your account* details) in *your direct debit request* confidential. *We* will make reasonable efforts to keep any such information that *we* have about *you* secure and to ensure that any of *our* employees or agents who have access to information about *you* do not make any unauthorised use, modification, reproduction or disclosure of that information.

7.2 *We* will only disclose information that *we* have about *you*:

- (a) to the extent specifically required by law; or
- (b) for the purposes of this *agreement* (including disclosing information in connection with any query or claim).

8. Notice

8.1 If *you* wish to notify *us* in writing about anything relating to this *agreement*, *you* should write to ***P O Box 364 Lithgow NSW 2790***

8.2 *We* will notify *you* by sending a notice in the ordinary post to the address *you* have given *us* in the *direct debit request*.

8.3 Any notice will be deemed to have been received two *business days* after it is posted.
